Please do not toss your old keys as you will still need them for entry to the gates to the parking lots and the pedestrian gate located on Troop Street. These locks have not been changed.

Each Unit will be assigned two keys fobs free of charge. If you requested additional keys, these will be provided to you as soon as they are received. The extra keys will be billed at \$10.00 each on your monthly assessments. Before you receive the extra key fobs, you will need to fill out a questionnaire of who will be receiving these key fobs. If you rent your unit, please contact the Owner of the unit and have them to fax or e-mail approval to give the two assigned key fobs as will as any additional key fobs that you have requested.

RE: Window Washing

The window washers are scheduled for the week of September 11, 2006 (weather permitting) and should take 4-5 days. If rain prevents the washers from working any of the scheduled days, then of course, the project will take longer.

In order for this project to be successful, all screens must be removed from your windows by September 11 (Sliding door screens may be left in the tracks provided they are left unlocked.) If a screen is not removed, that particular window will not get washed, and Vanguard Lofts will not get a refund for the passed-over window.

Also, a note of caution: I suggest you do not leave your screens on your balcony, as they could easily blow away, possibly injuring someone.
